Artwork requirements


Our Art Department is able to work to the most exacting standards to ensure that the Final product is a faithful rendition of the art reference you submit (within the limitations of our technology). However, more often than not, our clients rely on the extensive experience of our Art Department to design a good-looking product within certain broad parameters. In either case it is imperative that the art references you submit adhere to the following guidelines.

Suitable VECTOR artwork must be supplied or artwork will be charged at an hourly rate. REVISIONS will be subject to a \$ 25.00 (c) charge per revision.

FILE FORMAT REQUIREMENTS

OUR ART APPROVALS

Please refer to Figure B. for an example of how our legend will look on the art approval form. It will display a small description of the piece, the size and a legend describing plating and color location. In general the black & white art represents the metal portion of the item. Black indicates raised metal surfaces and white indicates recessed metal surfaces.

Artwork with colors (excluding 4 color process) will show color locations accompanied with a legend of colors used. Recessed metal surfaces may be color filled provided the color is totally outlined by raised metal in order to contain the epoxy. Recessed metal may be textured when there is no epoxy fill, in such cases "RECESSED & TEXTURE EXCEPT SMALL AREAS ARE TO BE SMOOTH" will be indicated.

USING PANTONE NUMBER (PMS) TO SPECIFY COLORS

- Specify the Pantone number (pms) when available.
- Spot color printing or colorfilling pms numbers must always be provided.
- Pls note PMS matching is not available for 4 color process printing.

ART SENT BY FAX

- Do not send photographs by fax.
- Send black and white art reference as clear and large as possible.
- It is preferable to send a colored art reference by mail (hard copy) with a legend that specifies color location and other details.
- Art work sent via fax or mail can be subject to an hourly rate charge.
